### STATEMENT:

*This certificate is issued by Marsh B.V. in its capacity as insurance broker to NautaDutilh N.V. for the purpose of information and evidence of cover for the policyholder, insured companies and insured persons, only. The information contained herein does not substitute, replace or override the original insurance policy.*

On behalf of NautaDutilh N.V. a professional indemnity policy has been effected with a total limit of coverage of EUR 250.000.000 any one claim\*. The coverage is structured on a layering basis. A possible loss will be paid initially from the primary policy of EUR 10.000.000. Above –if necessary- a loss will be paid from the 4 excess policies up to amount of EUR 250.000.000

The coverage applies to lawyers, notaries, tax lawyers and other advisors associated with NautaDutilh, located in all offices of NautaDutilh: Rotterdam, Amsterdam, Brussels, Luxembourg, London and New York, next to possible local insurance.

The deductible is EUR 90.000 anyone claim. The inception date of the policies is July 1, 2017 the policies will be run till 31 December 2018, both days inclusive followed with a tacit renewal of 12 months.
